2027-2028 Fulbright Foreign Student Program

Application Now Open!

Application Deadline: June 04, 2026

The U.S. Embassy in Algeria is pleased to announce the opening of the 2027 Fulbright Foreign Student Program application. The Fulbright Foreign Student Program supports graduate students from Algeria to research and study in the United States for one year or longer at U.S. universities or other educational institutions. Participants experience life in the United States and share their culture and traditions with Americans.

Participants will be selected through an open, merit-based competition in which leadership potential, academic excellence, and the ability to adjust to life in the United States are considered. By receiving a Fulbright Foreign Student Program award, participants become part of a global network of Fulbright participants and alumni.

The Fulbright Foreign Student Program is a program of the U.S. Department of State with funding provided by the U.S. Government and is administered by Amideast in the Middle East and North Africa region.

Selected candidates should be available for interviews in Algiers during the end of the month of June 2026. In addition, Fulbright participants are subject to section 212(e) of the Immigration and Nationality Act, which is a post-program home-country physical presence requirement. Upon completion of their Fulbright Program, participants are required to return to and reside in their home country or territory for an aggregate of two years before being eligible for U.S. immigrant and certain nonimmigrant visas. What does the Fulbright Program provide?

- Tuition and required fees for graduate study or research in the United States.
- Book, equipment, and travel allowances.
- Monthly stipend for accommodations and meals.
- A limited health benefits plan.
- Opportunities to participate in Fulbright enrichment programs.

Who is eligible to apply?

- Applicants must be citizens of or permanent resident able to hold a passport from Algeria.
- U.S. citizens or legal permanent residents are ineligible.
- Applicants must reside in Algeria throughout the application, selection, nomination, and placement processes.
- Applicants must hold a bachelor's degree from an accredited institution (4 years program under the classical system or 5 years program under the LMD system (License plus M1/M2 degrees) by the program start date.
- Applicants must have a strong academic background.
- Preference is given to applicants who have little or no previous experience studying or living in the United States.
- Applicants must be proficient in English or able to attend a Long-Term English (LTE) program prior to the start of their academic program.
- Applicants may apply for most fields of study, including the humanities, social sciences, science, technology, and engineering. However, programs involving clinical studies, such as medicine and nursing, are not permitted. Non-clinical programs, such as public health

and nursing administration, are permitted.

- Applicants must have at least two years of professional work experience after graduation.
- Applicants of all backgrounds, including those with disabilities, are encouraged to apply.

What is the application process?

Complete an application on the [2027 Fulbright application website](#). Ensure that you are selecting the **2027-2028 cycle** when completing your application.

Applicants will be required to submit:

- ❖ Original BA and MA diplomas and their certified translations, if originals are not available in English.
- ❖ Original BA and MA transcripts and their certified translations, if originals are not available in English.
- ❖ TOEFL, IELTS, or Duolingo scores (*if available*).
- ❖ A current résumé or CV detailing all prior education and work experience.
- ❖ Three letters of recommendation, in English or certified translations into English.
- ❖ A personal statement, in English, up to 600 words in length.
- ❖ A study/research objective statement, in English, relating to the field of study or research.
- ❖ Copy of passport (*if available*).

Application tips:

- Write clearly, using professional and understandable language.
- Demonstrate why you have chosen your field of study and how you are uniquely qualified to participate in the Fulbright Program.
- Use specific examples from your previous academic, professional, and personal experience.
- Proofread all materials for grammatical errors and spelling mistakes.
- Refrain from using sarcasm, jokes, or inappropriate humor.
- Cite any outside sources used in your essays. Plagiarism is a serious offense and may result in disqualification.
- Copying language/content produced by Generative AI directly into your application may negatively impact admission or affiliation decisions.
- All submitted work should be your own, based on your own original thoughts, ideas, and level of English language proficiency.
